Description

Invitation to Bid for the Supply and Delivery of various medicines for patients at Municipal Health Office, Aleosan, Cotabato

- 1. The Local Government Unit of Aleosan through Maintenance and Other Operating Expenses (MOOE) intends to apply the sum of One Hundred Forty-Nine Thousand Eight Hundred Ninety Pesos (P 149, 890.00) being the ABC to payments under the contract for Supply and Delivery of various medicines for patients at Municipal Health Office, Aleosan, Cotabato with Project ID No. PBG-2025-004. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Aleosan now invites bids for the above Procurement Project. Delivery of the Goods is required by Ten (10) calendar Days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from Local Government Unit of Aleosan and inspect the Bidding Documents at the address given below during Monday- Friday 8:00 AM-5:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on February 7-27, 2025 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (P 500.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees whether presented in person, by facsimile, or through

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before February 27, 2025 at 9:00 a.m. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB
- 9. Bid opening shall be on February 27, 2025 at 9:00 a.m. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Local Government Unit of Aleosan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
