Description

Invitation to Bid for the Installation of Solar Power Streetlights (40 units) at Brgy. San Mateo, Aleosan, Cotabato

The LGU ALEOSAN through the 20% Development Fund CY 2025 intends to apply the sum of Two Million Pesos (P 2, 000, 000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Project ID No. PBCW-2025-001: Installation of Solar Power Streetlights (40 units) at Brgy. San Mateo, Aleosan, Cotabato. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU Aleosan now invites bids for the above Procurement Project. Completion of the Works is required Sixty (60) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from LGU Aleosan and inspect the Bidding Documents at the address given below from Monday-Friday at 8:00 a.m.-5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on February 12-March 4, 2025 from given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.
- 6. The LGU Aleosan will hold a Pre-Bid Conference on February 20, 2025 at 10:00 a.m. at 2nd Floor, Municipal Budget

Office, Municipal Hall Building, Aleosan, Cotabato.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before March 4, 2025 at 10:00 a.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on March 4, 2025 at 10:00 a.m. at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The LGU Aleosan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
