The Local Government Unit of Aleosan through 20% Development Fund CY 2020 Continuing Fund intends to apply the sum of Two Hundred Forty-Nine Thousand Three Hundred Pesos Only (P 249, 300.00) being the ABC to payments under the contract for Supply and delivery of materials use for Installation of Water System for Housing Project at Barangay Palacat, Aleosan, Cotabato with Project ID No. PBG-2025-011. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Aleosan now invites bids for the above Procurement Project. Delivery of the Goods is required by Twenty (20) calendar Days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on April 8, 2025 at 9:00 a.m. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
