Description

Invitation to Bid for the Concreting of Municipal Access Road at Barangay San Mateo, Aleosan, Cotabato

The LGU ALEOSAN through the SGLG-IF intends to apply the sum of One Million One Hundred Fifty-Three Thousand Pesos (₱ 1, 153, 000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Project ID No. PBCW-2025-004: Concreting of Municipal Access Road at Barangay San Mateo, Aleosan, Cotabato. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The LGU Aleosan now invites bids for the above Procurement Project. Completion of the Works is required Fifty-Eight (58) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
